WHAT:

- Teams will be given one hour to create an appetizer and an entrée using two secret seafood ingredients, which are generally announced just before the event begins, and a “pantry” table containing everything the chefs should need.
- Each team will need to prepare 4 plates of each dish: 3 for judging / 1 for display, or a total of 8 plates. Each team may also prepare an additional dish, if they wish, for the event emcee to share with audience members.

- Each chef may bring an assistant.
- Each Chef must bring any cooking utensils needed – pots, pans, ladles, knives, plates, etc.
- Chefs will be made aware of their time slots the evening prior to the event. These time slots will be drawn at random by the event committee.
- Butane burners, blenders, mixers, etc. WILL BE provided by event committee.
- Chefs are NOT permitted to bring grills, ovens, toasters, blenders, food processors, etc. Chefs may NOT bring any outside food ingredients. This includes spices, etc.

Failure to comply with any of the above will result in immediate disqualification

Creativity

The winners will be announced and the prizes awarded at the end of the day, approximately 4 pm, at the main stage.
